### **Evidence of UK Government Lack of** Coordination

EGAD is aware of a number of unsubstantiated reports from companies of instances in which they have been misled by UK Government officials into seeking to pursue potential overseas business opportunities, the subsequent export licence applications for which have then been turned down. What the ECO is now seeking is some detail of these cases, so that they can identify the scale of this problem.

If any companies have experienced such instances, they should contact Brinley.Salzmann@adsgroup.org.uk, stating what country was involved, what sector was involved, and what UK Government department was involved, so that the information can be consolidated and submitted by EGAD to the UK Government.

### **News: Report of the House of Commons Committee on Arms Export Controls**

On Friday 20<sup>th</sup> March 2015, the House of Commons Committee on Arms Export Controls (otherwise affectionately known as the CAEC www.parliament.uk/business/committees/committees-a-z/othercommittees/committee-on-arms-export-controls/) published its latest report on UK export controls, in 3 volumes.

Of particular interest to EGAD may be the section on organisational and operational issues including the Committee asking whether the Government will "engage in detailed and constructive discussions with EGAD to establish whether EGAD's frustrations in dealing with ECO, as recounted to the Committees, are historic or current, and, if the latter, whether it will take the earliest possible steps to try to resolve them".

It is noticeable that there has been remarkably little media coverage of the release of the CAEC's latest report, in comparison to the publication of previous reports. The Independent has run a story on the report (www.independent.co.uk/news/uk/politics/government-accused-of-allowingarms-manufacturers-to-export-in-secret-10120718.html) - but, other than that, the report appears to have received little media coverage, outside of the "usual suspects", including CAAT (www.caat.org.uk/media/press-releases/2015-03-19), Russia Today (http://rt.com/uk/243085-uk-arms-human-rights/) and a number of Iran-related media outlets!














### **Export Licensing "Agony Aunt"**

Q1 - "We are supporting a client with a proposal to the Czech MoD for body armour working with a Czech company as prime.

The Czech company has asked us to produce an 'authorisation to trade with military material' in accordance with European Directive 2009/43/EC. Neither I nor the company I am supporting, who have previously exported worldwide, have heard of this requirement. Can you throw any light on it please?"

A – UK firms are increasingly coming across this. In some nations, defence firms have to register to operate and trade, but, of course, we do not have that requirement here in the UK. Therefore, most UK firms simply send overseas customers a copy of their export licence and of the ECO's covering letter, and this has satisfied them.

Q2 - "We are currently supplying some components to Dassault Aviation for use in its Rafale combat aircraft programme. So far we have been able to make use of the OGEL (Military Goods, Software and Technology) to facilitate these shipments, as until now the Rafale had only been in service with the French Armed Forces. However, as of 16<sup>th</sup> February, when the contract was placed for the sale of 24 x Rafales to Egypt, and with the subsequent sale of 36 Rafales to India, this is no longer valid to cover these export sales. Dassault has approached us to let us know that it intends to divert those systems, sub-systems and components which had previously been supplied to it, for incorporation into the aircraft to be built for Egypt. What should we do?

A – This has now been raised with us by a number of UK firms who are in exactly the same position. The Export Control Organisation is already well aware of this situation, and any UK firms in this position should make contact with their Compliance Inspectors to discuss their licensing needs with them.
