News: Appeal Court Decision on the UK Government's Licensing Policy towards Saudi Arabia and its allies

Members will be very well aware of the Appeal Court decision of 20th June relating to the UK Government's export licensing decision-making policy for the supply of controlled items to the members of the Saudi Arabia-led coalition which is actively engaged in the current, on-going civil war in Yemen.

The Government issued a Notice to Exporters on 25th June (<https://www.gov.uk/government/publications/notice-to-exporters-201909-court-of-appeal-judgment-about-military-exports-to-saudi-arabia/notice-to-exporters-201909-court-of-appeal-judgment-about-military-exports-to-saudi-arabia>), and then the details of six revised OGELs on 18th July (<https://www.gov.uk/government/publications/notice-to-exporters-201911-6-new-ogels-issued>) in response to this judgement.

The EGADD Secretary has been dealing with a number of queries from companies since the 20th June ruling, and the ECJU has now asked him to try to compile a consolidated listing of any, outstanding queries which UK Industry still has, which have not been clearly answered in the above documents.

Review of the ECJU's Website Guidance

The ECJU is currently undertaking a fundamental review and consolidation of the many and various guidance documents that are presently available from the GOV.UK website, to try to rationalise these and remove out-of-date guidance.

EGADD's Awareness Outreach Activities Sub-Committee has been playing a crucial role in these endeavours by providing an Industry viewpoint on this rationalisation process, to try to ensure that nothing useful for companies is lost in the transition process to the new format.

However, the ECJU is now desperately seeking a wider Industry input on which existing documents, and guidance documents which are currently on the GOV.UK website companies find useful and feel that they need to be retained. They cannot keep everything as part of the rationalisation process, but they need to know what documents can be safely archived, and which need to be retained and kept updated.

Therefore, we would be immensely grateful if companies could please provide some input to Brinley.Salzmänn@adsgroup.org.uk on which guidance (or other) documents currently available via the GOV.UK website they regularly use, and would want to see retained at the end of the rationalisation process.

HMRC Import Tax Changes

EGADD has been asked to bring to EGADD Members' attention the information at: <https://www.gov.uk/government/publications/revenue-and-customs-brief-2-2019-vat-import-vat-deducted-as-input-tax-by-non-owners>. This HMRC brief explains the correct treatment for the deduction of import VAT paid by a taxable person who is not the owner of the relevant goods. It also explains what actions HMRC will take in relation to incorrect claims for previous periods. You should read this brief if you are:

- a non-owner who has reclaimed import VAT on goods imported into the UK
- a 'toll operator'
- advisers or agents dealing with businesses importing goods to the UK

When this OGEL (<https://www.gov.uk/government/publications/open-general-export-licence-information-security-items>) was first published, in April 2018, it was stated both at the time and subsequently by a UK Government Minister at that year's ECJU Symposium, in London, that HMG would welcome feedback from Industry on how its utility could be improved. We (EGADD and techUK's TCCG) have now been asked to seek comments from companies on this, which can be fed into HMG for its consideration, with a view to enhancing the utility of future iterations of this OGEL.
